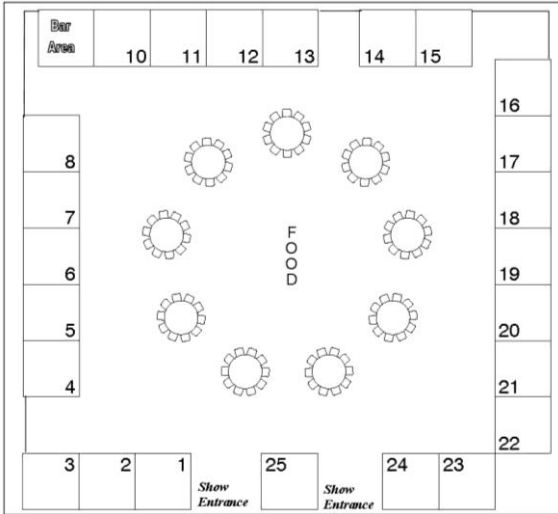

The South Central Wall, Ceiling & Plaster Association (hereinafter referred to as SCWCPA) offers to lease to

Lessee agrees to be bound by the terms and conditions set forth on both pages of this contract, the rules and regulations, and such additional conditions as may be established by the management or owners of the show facility.

Conditions

1. Each person staffing an exhibit table in the Exhibit area **must** be registered at the SCWCPA Convention. Booth rental fee includes one paid registrant; additional booth worker must register and pay the fee below. Lessee's contract must be paid in full before erection of the booth will be permitted.
2. Exhibit space is available on a first come, first serve basis. The SCWCPA must receive all contracts by May 21, 2012. ***Any contract received after this date will be allowed to exhibit only if space is still available and will be subject an additional \$100 per exhibit table.**
3. **All exhibits must conform to the size of the space and must not exceed 10 feet in width and 10 feet in depth or be of such nature or arrangement as to obstruct the view of or interfere with exhibits of others.** Should there be any question as to obstruction or interference of any exhibit with other exhibits in the area; or the location of any exhibit, the final judgment will be made by the SCWCPA Executive Director.
4. SCWCPA assumes no responsibility for the property of Lessee. Loss to property of Lessee from theft, vandalism, fire or other cause is solely the responsibility of Lessee. It is expressly understood and agreed that Lessee will hold harmless and make no claim of any kind against SCWCPA or any of its members or employees for any loss, damage to or destruction of property, nor for any injury that may occur to himself, his or its agents or employees while in the show facility, nor for any damages of any nature or character whatsoever, including direct or indirect damage as a result of loss of business arising out of the show or cancellation of it.
5. SCWCPA reserves the sole right to cancel the show for any reason satisfactory to it. If the show is canceled, SCWCPA will refund to Lessee all monies paid by Lessee.
6. The Hotel requires that the following statement be included in this contract:
"The exhibitor assumes the entire responsibility and liability for losses, damages, and claims arising out of exhibitor's activities on the Hotel premises and will indemnify, defend and hold harmless the Hotel, its agents, servants and employees from any and all such losses, damages and claim. Hotel will not be responsible or liable for any loss, damage or claims arising out of exhibitor's activities on the Hotel premises except for any claims, loss or damages arising directly from its negligence."
